This is to protect the interests of all participants. No Exceptions! Example: Face painting, Balloons, Cookies, etc.) Write on the back of the application if you need more space.

We will limit the number of similar booths. We will try not to have more than 3 booths of the same type. ***There will only be one booth of a type for food items.*** Acceptance will be on a first come first serve basis when application and fee are received.

- Band Students and Band Parents: Please understand this, ***If more than one student is going to share a booth, each student participating in that booth must pay a \$20.00 booth fee.*** For example, if 4 students are doing a booth together, the fee for that one booth is \$80.00. The only exception to this is if the students are siblings.
- Booth space will be 12 X 12. If you will require more space than this, please indicate so on your application. We will make every attempt to accommodate you but in some cases it may be impossible.
- ***The band concessions will be hamburgers and hotdogs, chips and drinks. There will be no other hamburger or hotdog vendors allowed.***
- If electricity is required for your booth we must know in advance and you must supply your own cords. A \$5.00 fee will be added for electricity.
- You will need to have your own change box and change. You will need to supply your own tables, canopy, chairs, and any other equipment you made need to operate your booth.
- You are responsible for your own set up and clean up before leaving for the day.
- Your application must be returned by September 13, 2008. Entry fees are non-refundable after September 6, 2008.
- **Set up may begin at 7:00 am and must be complete by 9:00 am. Vehicles, and other equipment used to transport, must be moved to the designated parking lots by 9:00 am and cannot come into the vendor areas until after 3:00 pm.**
- By applying for a booth and signing this agreement you are accepting the conditions and agreeing to abide by the rules.
- We will not assign booth spaces before Thursday, September 18th. PLEASE do not contact us prior to this to find out where you will be.
- DeSoto Central High School nor the DeSoto Central High school Marching Band will be held liable for any accidents or damage to your property.
