- ❖ Booth application deadline is Friday, September 29th. Booth assignments will be made by Wednesday, October 4th.
- ❖ We will attempt to limit booth types to no more than 3 booths of the same type.
- ❖ Acceptance based on receipt date of signed application WITH PAYMENT.
- ❖ Booth space is 12'x12'. If you require more space, indicate in Booth Description. We will contact you.
- ❖ Each booth is responsible for its own change box, change, tables, canopies, etc. (Canopies MUST be secured/staked.)
- ❖ If signing up for electricity, each booth must provide GROUNDED 120V 15A electrical cords from our provided outlet.
- ❖ Setup hours: Saturday 7am-9:30am. All vendor vehicles and trailers must be in designated parking areas by 9:30am Saturday and cannot return to vendor area before 3:45pm.
- ❖ Alcohol, tobacco, and weapons of any kind are illegal on school premises. Merchandise should be suitable for all ages and not contain offensive messages. No toy guns that are realistic in appearance are allowed.
